Behaviour principles written statement

Inspire Education Community Trust is committed to ensuring high behavioural standards for all pupils, and this statement sets out the broad values and principles with regard to behaviours that are expected and promoted. This statement has been approved by the executive headteacher believing it accurately reflects the school's ethos and that effective learning and development relies on good standards of behaviour.

Actual, practical applications of these principles are the responsibility of the head of school, who will view each case in light of these principles and any relevant policies.

Principles

The school's primary concern is the safety, wellbeing and education of all pupils; actions taken in cases of bad behaviour are with the intention of upholding their wellbeing and academic progress, as well as fulfilling our safeguarding responsibilities.

The schools will create a calm and orderly environment to enable pupils to learn effectively.

The schools prioritise inclusion and will ensure that all members of the school community are able to enjoy the activities of the schools free from any discrimination. The schools will create and maintain an atmosphere and ethos of acceptance, equality, diversity, respect, understanding and kindness throughout the schools' community in everyday practice. The schools aim to foster a collective ethos amongst all members of the school community, and promote values of caring, empathy, teamwork and coordination.

The schools endeavour to ensure that all pupils, staff and visitors feel safe in the school environment at all times through a high quality of care, support and guidance.

All pupils have a right to fulfil their greatest academic and personal potential and feel they are valued members of the school community, and should be free from bullying, discrimination and distracting peer behaviour.

The schools ensures that rules that reflect and are consistent with the messages taught across the curriculum are consistently applied across the schools and, where sanctions are exercised, they are in line with the school's **Behaviour Policy** and are taken seriously. Good behaviour at schools is acknowledged and rewarded at the discretion of all staff, who will judge appropriately.

The schools offer comprehensive support to pupils displaying problematic behaviour, before and/or alongside disciplinary measures, taking into account pupils' home circumstances and any SEND.

Any kind of violence, threatening behaviour or abuse between pupils, or by members of the school community towards the school's staff, will not be tolerated. If a parent does not conduct themselves properly, the schools reserve the right to ban them from the school premises and, if the parent continues to cause disturbance, they may be liable to prosecution.

Guidance on the use of physical intervention will be agreed upon by the executive headteacher and Trust and is clearly set out within the school's **Behaviour Policy** and **Physical Intervention Policy**.

The schools uphold clear and effective policies with clearly defined consequences for poor behaviour, that are applied consistently and fairly by all staff.

General expectations

The schools have high expectation for pupils' behaviour and conduct. These expectations are commonly understood and applied consistently and fairly. The schools set clear routines and expectations for the behaviour of pupils across all aspects of schools life, not just in the classroom.

The schools make behavioural expectations and the related policies clear and accessible to members of the schools community, and ensures the community agrees they are fair and reasonable. These will be made readily available to read and general expectations will be displayed in classrooms and around the school. The school's emphasis is on encouraging and praising good behaviour and supporting individuals who are struggling to meet the expected behavioural standards. Each pupil receives the necessary behavioural support according to their specific needs.

The schools create a positive and respectful culture in which staff know and care about pupils. The schools does not tolerate offensive or insulting language in any circumstances and expects polite and considerate behaviour to be maintained by all. Bullying, discrimination, sexual harassment, sexual abuse and sexual violence are not tolerated, online or offline. The schools effectively address harmful sexual behaviour in the **Behaviour Policy**, which details appropriate sanctions that are applied consistently. Pupils are encouraged to report any case of bullying they experience or observe to school staff, and wherever such behaviour occurs it will be dealt with quickly, consistently and effectively.

The schools support pupils to play a highly positive role in creating an environment in which commonalities are identified and celebrated, difference is valued and nurtured, and bullying, harassment and violence are never tolerated. All pupils are taught to actively support the wellbeing of other pupils.

All pupils are expected to behave consistently well, demonstrating high levels of self-control and consistently positive attitudes to their education.

Pupils are held to high standards of attendance. The schools will take swift, appropriate and action to ensure that problems of lateness and absence are handled effectively.

Staff lead by example and model their conduct in line with the school's standards. This statement, and the policies that are influenced by it, applies to all pupils and staff inside and outside of school.
